## What's New in E-rate

---

- *Consumer's Union v. FCC* resolved
- Likely changes to eligible services
  - Removal of hotspot lending services and school bus wi-fi
    - Should not impact bookmobile wi-fi
- USF Reform
  - Primarily around contributions, but could impact programs/services
- Calls for new Telecom Act

## Origin of E-rate and Available Funding

- Comes out of Telecom Act of 1996
  - Most subsequent changes the result of Federal Communications Commission (FCC) action, rather than Congressional action
- Discount Program on Eligible Services
- E-rate does not reach its funding cap – funding is available

## MA Libraries and E-rate

- FY2024: Libraries approved for \$944k, have invoiced for \$891k
- FY2025: Libraries already approved for \$1.57M, with almost \$200k still under review

## Application Process Overview

- Procurement: **Form 470** and (optional) RFP
  - Bid Evaluation and Contract Award
- Application for Funding: **Form 471**
  - PIA review and award of funding (FCDL)
- Notification of Services Starting: **Form 486**
  - Receipt of services and compliance with CIPA
- Invoicing: **BEAR (Form 472)** or **SPI (Form 474)**
- Post-Invoicing: Audits, reviews, etc.

## FY2026 Expanded Timeline

- *All dates are estimates*
- Funding Year: July 1, 2026 – June 30, 2027
- Procurement/**Form 470**: July 2025 – December 2025
- Admin Window: mid October 2025 – mid January 2026
- Bid Evaluation and Contracting: November 2025 – February 2026
- **Form 471**: mid January 2026 – late March 2026

## FY2026 Expanded Timeline

- PIA Review and FCDL: April 2026 – July 2026
- **Form 486**: May 2026 – September 2026
- Last date for recurring services: June 30, 2027
- Last date for non-recurring services: September 30, 2027
- Invoicing **BEAR (Form 472)** or **SPI (Form 474)**: July 2026 – October 2027/January 2028

## Review of Eligible Services

- Eligible services divided into two categories:
  - Category 1 (Data and Internet) Services
  - Category 2 (Internal connections, Basic Maintenance of Internal Connections, Managed Internal Broadband Services)
- Eligible services list revised each year
  - ESL draft for FY2026 has not yet been released
  - Anticipate ESL will remove Wi-Fi hotspots, school bus Wi-Fi

- Category 1 (Data and Internet) Services to Library Facilities
  - Traditional Connectivity Services to Library Facilities
    - Ethernet Service
    - T-1, T-3, OC-1, OC-3, etc.
    - Cable modem, DSL
    - Satellite

## Review of Eligible Services: C1 (cont'd)

- Category 1 (Data and Internet) Services to Library Facilities
  - Fiber Services
    - Leased Dark Fiber
    - Leased Lit Fiber
    - Self Provisioned Broadband Networks\*
  - Wireless Data Services to Bookmobiles\*
  - Some terminating network equipment

\* Requires RFP

- Internal Connections (IC)
  - Hardware
    - Routers
    - Switches
    - Firewalls
    - Wireless Access Points
    - Wireless Controllers
  - Some licenses
    - Client Access Licenses
    - Right of Use Licenses

## Review of Eligible Services: C2

- Basic Maintenance of Internal Connections (BMIC)
  - Limited to eligible internal connections
  - "In Person Services"
    - Time and materials or otherwise contracted services
  - "Remote Services"
    - Basic support
    - Software upgrades
  - Some licenses ("maintenance")
    - Software updates and upgrades
    - Security updates and upgrades

## Review of Eligible Services: C2

- Managed Internal Broadband Services (MIBS)
  - Limited to eligible internal connections
  - Remote management/administration of internal connections components
    - Firewall management
    - Wireless network management
    - Network monitoring
  - Leased, managed equipment
- Lines between MIBS and IC/BMIC can become fuzzy but are critically important

## Conditional Eligibility

- Services are only eligible to the extent they are used by eligible entities at eligible locations for eligible purposes
- Conditional eligibility when
  - Mixed eligible and ineligible components (e.g. firewalls, licenses)
  - Eligible and ineligible locations (e.g. library sharing services with town hall)
  - Eligible and ineligible uses (e.g. library is multiuse facility)
- Conditional eligibility "cured" by cost allocation using tangible criteria to achieve a reasonable result

## Conditional Eligibility Example

- Library and Town Hall share Internet connection which costs \$1,000/mo.
- Library has 8 computers and Town Hall has 2 computers
- Library is eligible for a 60% discount
- Library uses number of computers for cost allocation.
- Monthly reimbursement/discount is:  $\$1000 * 80\%$  (for computers)  $* 60\%$  (for discount) = \$480

## New C2 Budget

- Category 2 requests are constrained by a budget based on square footage for libraries
- FY2026 is the first year of a new C2 budget cycle – new budgets are ~20% higher than previous cycle
- Data will be available at [opendata.usac.org](https://opendata.usac.org) and in EPC after mid-October
  - Remember, C2 budget applies to *pre-discount* cost – i.e. your discount is applied against that C2 budget
    - E.g. if your C2 budget is \$100,000, and your discount rate is 60%, you can order up to \$100,000 of eligible equipment and receive discounts or reimbursements worth up to \$60,000.

## New C2 Budget

- Will need to validate data first time you apply during the new cycle
- Online tool will list C2 budgets as "Forecast," "Preliminary," or "Confirmed"
  - Forecast is USAC's estimate
  - Preliminary is based on library application that hasn't yet been funded
  - Confirmed is based on funded library application
- Online tool will automatically calculate budget for you (available after mid-October)

## C2 Budget Examples

- Libraries/library systems funded at \$5.43/sq. ft.
- Funding floor for any entity is \$30,175
- Any individual library under 5,557 sq. ft. would be at the funding floor (\$30,175)
- 12,000 sq. ft. library would have a prediscount C2 budget of \$65,160 ( $12,000 * 5.43$ )
- Remember, online system will do calculations automatically

## CIPA

- CIPA applies to all E-rate applications that include Internet Access or any Category 2 services
- CIPA requires internet safety policy, technology protection measure, public notice and a public meeting
  - Make sure you have the documentation in your files

## Procurement Guidelines

- Procurement process must be “fair and open”
  - Fair: every vendor evaluated fairly and equally
  - Open: same information available to all potential vendors
  - Bottom line: all vendors must be treated the same, fairly, and equally
  - No preferential relationships with service providers
    - No ownership stakes in service providers
- Gift rules exist to help preserve fair and open
  - No gifts over \$20 value, no more than \$50/yr.
  - Advice: DO NOT ACCEPT GIFTS

## Procurement Guidelines

- Procurement is the most critical part of the E-rate process
    - Difficult to remedy errors
    - Remediation usually involves starting over – which is a problem since you normally only find out about problems after it's too late to start over
  - Vendor involvement with the procurement process (e.g. needs assessment) can/will taint the procurement process
- DO NOT GET VENDOR ASSISTANCE WITH PROCUREMENT

## Procurement Process

- Identify needs
- Determine procurement options that work best for you
- Draft procurement (470/RFP) based on needs
- Release RFP and Form 470 (as applicable)
- Wait at least 28 days
- Evaluate bids and select service provider

## Identify Needs

- Determine current status of services
  - Current services and specifications
  - Contract Status
  - Whether current service meets current/future needs for upcoming funding years

## Determine Procurement Options

- Option 1: Just file a 470 (no RFP)
- Option 2: File a 470 and RFP
- Option 3: Use State Contract (ITT72)
- Option 4: Use CABIO or Tribal Libraries Exception

## Draft Procurement: 470/RFP

- Identify the services of interest
- 470 includes services and quantities you are seeking
- Can include links to outside regulations and related documents
- Can include RFP if RFP exists for some or all services

## Draft Procurement: 470/RFP

- RFP is optional (unless required under state/local regulations) except for bookmobiles
  - RFP is any document that provides information about the services sought or the bidding process
  - If RFP exists, it must be attached to the Form 470
    - Any modifications/addenda must also be attached
    - Can reset 28 day clock
- RFP can be simple or complicated based on your needs

## Draft Procurement: 470/RFP

- If you want to prepare an RFP, talk with us
  - Hundreds of RFPs available online and through EPC
  - Some sample RFPs available via MBLC
- New sample bookmobile RFP coming soon

## Release Form 470/RFP

- Form 470 and RFP must be released at same time
- Once Form 470 and RFP are released you can solicit bids
  - Do so neutrally and widely
  - Do not provide inside information
  - Recommend direction to the Form 470/RFP for information

## Wait at least 28 days

- After the Form 470 is released, applicant must wait at least 28 days before closing the bidding
  - Can wait longer
  - Allowable Contract Date (ACD) on 470 Notification Letter is the earliest date bidding can be closed
  - 28 day waiting period is restarted if there are significant changes posted to your application (e.g. addenda/amendments to RFP)

## Evaluate Bids/Select Winning Service Provider

- Must evaluate all bids using an evaluation matrix
- Price of eligible goods and services must be most highly weighted factor
- Will cover in much more detail later this Fall

## Alternatives to Traditional E-rate Procurement: State Contract

- State Contract (ITT72) exists that allows libraries to bypass the Form 470 process
- Must still conduct a mini-bid process comparing the various vendors awarded under ITT72
- Guide for applying using state master contract at <https://mbic.state.ma.us/programs-and-support/e-rate/state-contracts.php>
  - Includes instructions, attachments, etc.

## Alternatives to Traditional E-rate Procurement: CABIO and Tribal Libraries

- Commercially Available Broadband Internet Offering (CABIO) – at least 100 Mbps down/10 Mbps up, commercially available, \$3,600/yr. or less
- Tribal Libraries Exception – Category 2 services costing less than \$3,600 per library can be purchased without a Form 470
